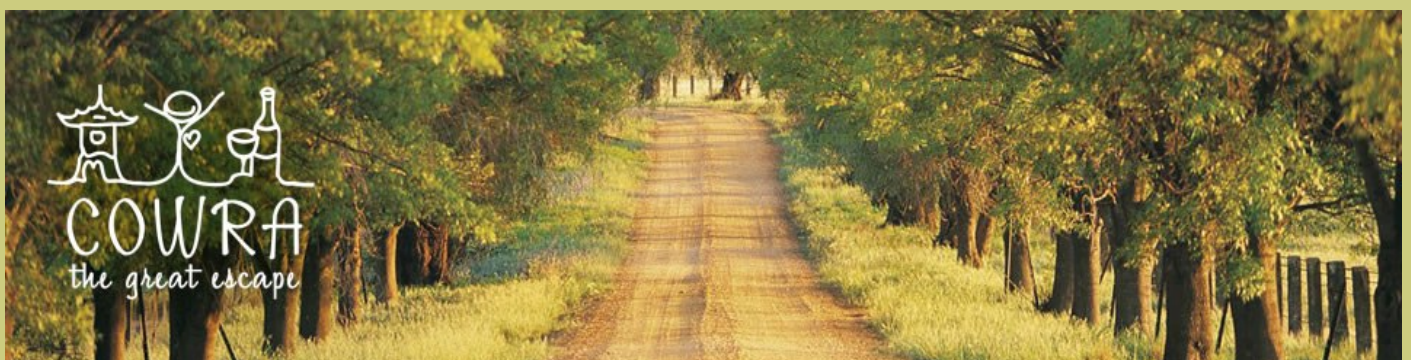

‘NSW Pool Rules’... new iPhone app!



Alan Stanger from Dubbo City Council has developed an iPhone app that explains swimming pool barrier rules for NSW pools and spas. As you would know, the rules and regulations regarding NSW swimming pools and spas are extremely complicated and there is widespread confusion about swimming pool barrier safety.

Alan developed the app for pool owners, pool inspectors, pool installers and for anyone in a similar profession that needs to know accurate and up-to-date pool rules, particularly the rules that apply to a pool based on the installation date of the pool.

The app is a great quick reference guide that can be used in the field. It is also very handy as an educational tool to help explain rules to pool owners as the app has hundreds of coloured isometric diagrams that are easy to understand. Information is quick and easy to find using the app's user friendly interface.

The app also clearly explains complex subjects such as doors and window requirements, what structures are permitted in pool enclosures and outlines anomalies that exist in pool legislation.

The information is date specific as the rules are different depending on the date the pool was installed. Another big advantage of this app is that it will be updated as changes occur to legislation.

Penrith City Council Mentoring Program

Melissa Aylward, Environmental Health and Building Surveyor from Orange City Council attended the Mentoring Program during September and was more than happy to share her experiences during the Program...

When did you attend the Mentoring Program:

I was in Penrith from Monday 2nd Sept to Friday 6th September 2013.

Who did you work with during the Program?

I worked mainly with Craig Squires who is the Supervisor Fire Safety. I also went on site visits with Colin Wood who is the Coordinator Fire Safety and Certification.

What did a typical day involve?

The days varied and were tailored to what I wanted to achieve out of the program. Craig was great and arranged a variety of inspections one of which was to the Centrebet Stadium (Home of the Penrith Panthers) to look at the accessibility and Colin took me on site visits for insights into Bushfire and subdivisions. The days were busy and interesting. We carried out a Fire Audit on a three storey walk up, I had to write the report! I also sat in on Development committees to observe staff dealing with applicants.

What did you learn during the Program

Too much to mention my mind was spinning at the end of each day. But just experiencing how other do the job on a day to day basis was great. I picked up snippets here and there to modify how we do things here in Orange – to not only improve my skills but to tweek processes.

I also learnt that we give out too much information for free! Mind you I cant see Orange residents paying for information from their Council when they pay their rates!

What did you gain most out of attending the Program?

I gained great experience in working in a larger Council, I participated and inspected properties that I would not get to do on the same scale in Orange.

I was amazed at how specialised the EH&BS are in the city. They are experts in their fields. However, I appreciate our (rural EH&BS) skills! To be a country EH&BS you must have varied and practical knowledge, and I see this as a skill that makes us very competent EH&BS.

Would you recommend the Program?

I would recommend the program. Especially if you have only worked in country Councils. It gives you great insights as to what we do really well out here in the bush and what we may need to improve on.

Any other comments?

I'd really like to thank Colin and Craig for letting me into their working lives and putting up with all my questions! And to EDAP for being involved in the program.
